The 2014-2015 Budget was presented. **Motion to approve the budget made by Robin Evans, seconded by Judy Correnti, and APPROVED by the Association.**


The Year-to-Date 2014-2015 Treasurer's Report for 7/1-9/8/14 was presented and **FILED for audit.**
